PRONUNCIAMIENTO DE LA REGIÓN AMÉRICA LATINA Y EL CARIBE DE LA FITS y COLACATS POR ACONTECIMENTOS EN PUERTO RICO

Las organizaciones miembros de la Región América Latina y El Caribe de la Federación Internacional de Trabajadores Sociales (FITS) y el Comité Latinoamericano y Caribeño de Trabajo Social (COLACATS) expresamos nuestro REPUDIO ABSOLUTO por LA REPRESIÓN A LA PROTESTA SOCIAL y ARRESTOS a Trabajadores Sociales, Estudiantes de Trabajo Social y otros manifestantes de Puerto Rico a raiz del Paro Nacional y la movilización llevada a cabo por la ciudadania en el marco del Día INTERNACIONAL DEL TRABAJADOR, quienes reclamaban legitimamente por sus derechos ciudadanos ante medidas de la Junta de Control Fiscal impuesta por Estados Unidos que afecta profundamente las políticas públicas, los servicios sociales, la Educación y el derecho a un Trabajo Digno para el Pueblo.

En este sentido lamentamos y manifestamos nuestra profunda preocupación respecto de la actitud adoptada por el Gobierno de Puerto Rico quien no sólo intimidó a los trabajadores para que no participaran de estas actividades bajo la amenaza de represalias y no renovación de contratos para los trabajadores que adhieran a estas medidas y participen de la movilización, sino que también mandó a las fuerzas policiales a reprimir la protesta social en donde fueron arrestados ciudadanos y ciudadanas de este país. En el marco de un Estado de derecho es insostenible este tipo de medidas y prácticas violentas y autoritarias que no hacen otra cosa atentar contra la forma de vida democrática dándole la espalda al Pueblo ante sus demandas sociales, políticas y económicas. Antes estos lamentables acontecimientos, expresamos nuestra solidaridad para con el Pueblo de Puerto Rico.

Asimismo, felicitamos y acompañamos las acciones que el Colegio de Trabajadores Sociales de Puerto Rico están llevando a cabo en pos de la defensa irrestricta de los Derechos Humanos, la Justicia Social y el ejercicio real y efectivo de la ciudadanía. La única lucha que se pierde es la que se abandona, así que estimados compañeros a no bajar los brazos, no están solos.

Endorse, advise and assist in legislative matters in those member countries that do not yet have a National Legislation that regulates the exercise of the profession.

Working with the Association of Social Workers of Mexico (ATSMAC) in order that Social Work is recognized as a Profession and incorporate Social Work into the General Catalog of Professions that depends on the Ministry of Public Education, since in that country it still exists as a craft job.

Work was carried out to approve the Draft Law on Professional Practice in Uruguay presented in the Parliament by the Association of Social Workers / Social Workers of Uruguay (ADASU). Endorse, advise and assist in legislative matters in those member countries that do not yet have a National Legislation that regulates the exercise of the profession.

Worked with the Association of Social Workers of El Salvador (ATSES) in order to request derogation the subsection "ñ" of Article 24 of the Health Code that links the Social Work in the field of Health. We also accompany the actions that are being carried out in the Ministry of Education (MINED) for the purpose of Social Work being recognized as a Social Sciences Profession. October 2017.

Worked with the National Council of Social Work of Chile in order to accompany the initiatives that the Association has carried out in the Parliament of that country, for the purposes of the Social Work Profession in order that the Work Social is recognized as a profession that is qualified to intervene in the field of health and requesting not to exclude Social Workers from the Code Sanitary of that country since it entailed placing at risk the continuity of 4000 Social Workers who are working in the field of health in Chile. Endorse, advise and assist in legislative matters in those member countries that do not yet have a National Legislation that regulates the exercise of the profession.

 Support and logistical advice to the Association of Social Workers of Panama, in defense of the rights of Social Workers, given that the institutions of that country have not made the payment of the Salary Scale.

Other achievements of the Region:

Work is being done jointly with the Latin American Association of Social Work Teaching and Research (ALAEITS) and the Latin American and Caribbean Social Work Committee (COLACATS).

At present, there is NO conflict between the members of the Region thanks to the leadership and work of their representatives and the permanent democratization and consultation in decision making.

Press conferences were held in several countries, highlighting the IFSW and the contributions of Social Work in the topics of the Global Agenda and the social problems that affect each country.
